1. Applications and payment must be received by August 28, 2026. Checks, cash, money orders, Visa, and MasterCard are accepted. After August 14, 2026, payments will include a \$25.00 late fee. **Booth fees and late fees are considered donations and refunds will not be issued for any reason (including weather). Vendor registration CLOSES on August 28, 2026.**
2. All vendors are responsible for providing their own 10 x 10 tent, tables, and chairs.
3. Inside booths are very limited. They will be filled on a first come first served basis. Inside booths are located at 404 Main Place. You must bring your tables and chairs. Limited booths with electrical hookups. No wi-fi access.
4. Outside booths will be placed along Main Street in front of existing businesses. Electrical hookups are not available. You must bring your generator if needed.
5. All vendors must sell from their booths only. No soliciting from any area other than your own rented booth. Booths must be maintained from 9:00 a.m. until 3:00 p.m. No breaking down early.
6. **No PA systems, speakers, or microphones** may be in use at vendor booths so as not to disrupt other vendors, guests or event announcements.
7. Applications must indicate items to be sold or displayed.
8. **NO READY TO EAT FOOD, FOOD SAMPLES, OR DRINKS** may be sold from craft and sales booths.
9. Each vendor is responsible for their trash cleanup after the event.
10. Each vendor is solely responsible for paying sales tax.
11. **All food vendors** are required to obtain a temporary permit from the Tarrant County Health Department at their own cost. Under no circumstance will a vendor be allowed to operate without a permit. **No food permits will be issued on the premises. Tarrant County Health Department #817-321-4960.**
12. All vendors using generators or cooking food, please be aware that the Azle Fire Department will be inspecting your area on festival day. If you have questions you can contact the Azle Fire Department #817-444-7051.
13. Vendors will be assigned booth spaces by festival coordinators. You will be contacted by email with your booth number, location, and other important information about one week before the event.
14. All booths must be safely constructed and not constitute a hazard. Walkways must remain clear at all times. Azle Police Department will be monitoring all traffic.
15. This is a family-friendly festival; profanity, alcohol, and tobacco products are not permitted.
16. Anyone violating any of the above rules may be asked to leave with no refund and can be denied participation in future festivals.
